Honoring Norman Knight

A Tribute to Norman Knight: The Visionary Founder of the 100 Club of Massachusetts, 1924-2024

Norman Knight was a man whose life embodied the values of service, generosity, and humility. As a founding member of the 100 Club of Massachusetts in 1959, alongside Howard Fitzpatrick, Richard Robie, and George Swartz, Mr. Knight dedicated his life to supporting the families of police officers and firefighters who made the ultimate sacrifice. The Club's guiding principle—"We care for those who care for us"—was not just a motto but a mission he lived every day.

Known for his "compassionate iron fist," Mr. Knight never sought recognition for his work. Instead, he focused on delivering comfort, support, and dignity to those facing unimaginable loss. To the widows and children of fallen first responders, he offered not only financial support but emotional connection—he made them feel seen, heard, and never forgotten.

His impact extended far beyond the Club's walls. After the 1994 warehouse fire in Charlestown that claimed Lt. Stephen Minehan's life and severely injured others, Mr. Knight learned Boston lacked a hyperbaric chamber for emergency oxygen therapy. Through his foundation, he made it his mission

to bring Hyperbaric Oxygen Therapy to the city, ensuring future responders would have access to lifesaving treatment.

Mr. Knight also played a pivotal role in establishing the Massachusetts Fallen Firefighters Memorial at the State House. He brought together stakeholders with diplomacy and grace, offering not only financial support but his steady leadership to realize a sacred space where the public can honor the bravery and sacrifice of firefighters.

Whether sitting with grieving families or advising leaders at the highest levels, Mr. Knight remained steadfastly humble and kind. As Boston Fire Commissioner Joe Finn noted, "He was as comfortable and compassionate sitting with a young widow whose life was just turned upside down, as he was advising Presidents of the United States."

Norman Knight's legacy is not just in the institutions he built or the lives he touched—but in the unwavering humanity he showed in every interaction. He will be remembered always, not only for what he did, but for how he made people feel: cared for, supported, and never alone.

How We Help

At the 100 Club, we extend benefits in both line-of-duty deaths and non-line-of-duty deaths. Leveraging a broad network of contacts within the police and fire departments and fraternal organizations across the state, the Hundred Club moves to quickly mobilize benefits to surviving family members. A summary of the benefits for each is below:



- Initial cash distribution of \$15,000 to the surviving spouse for immediate financial assistance to bridge the gap before benefits commence
- One-time cash disbursement from the James B. Crockett Memorial Fund, an endowed fund that will provide a benefit of \$25,000 each for the spouse and each dependent
- > Financial assistance for colleges, universities, trade or vocational schools in the amount of \$4,000 per semester for each dependent
- Payment for personal enrichment programs for children; camps, tutors, dance/music lessons, sports, school activity fees, gym memberships
- Invitations to social events such as Pops Concerts, Red Sox Games and our annual Holiday Party – that foster community
- Signal Financial assistance for health and wellness programs
- > Recognition gifts sent throughout the year, including birthday acknowledgments to the widows.
- Oheck for \$100 to high school graduate
- Additional benefits on an as-needed basis for individual beneficiary families

Non-Line-of-Duty Deaths

One-time payment of \$15,000 to the surviving spouse and \$5,000 to each minor child of any active-duty Massachusetts first responder irrespective of the cause of death to bridge the gap before vested benefits commence.





IMPACT: Voices of Resilience and Remembrance

At the heart of the 100 Club of Massachusetts is a commitment to the families of our fallen heroes—those who have given everything in service to their communities. Behind every name, every badge, and every sacrifice is a family left to carry on, facing unimaginable loss with courage and strength. In this section, we share the voices of those who have felt the profound impact of the 100 Club's support. Their testimonies serve as a powerful reminder of why we exist—to ensure that no family walks this journey alone and that the legacy of their loved ones is forever honored.



Holding on, letting go, remembering always

On Thanksgiving night in 2010, 33-year-old firefighter Ken Marshall, Jr. lost his life in the line of duty. A beloved husband, father, and third-generation firefighter, Ken suffered cardiac arrest while driving a fire engine to an emergency call. Despite every effort of fellow firefighters and paramedics, Ken did not survive.

Ken's oldest daughter, Brianna, was only six years old when her dad tragically lost his life. Even at that young age, she knew her dad was a heronot just because he wore a uniform, but because of the way he made her feel safe, loved, and full of wonder for the world.

He taught her everything—how to ride a bike, how to roller skate, how to fish and hunt, and how to live with a sense of joy and purpose. He was patient when she fell off her quad in the backyard, proud when she tried again, and never far when she needed encouragement. In every moment, big or small, he was right there, teaching her not just skills, but confidence and heart.

Some of her favorite memories are of their family trips to Santa's Village in New Hampshire, where

her dad's playful spirit came to life. He lit up that magical place as much as the lights did. Just as unforgettable were the times she got to ride along with him on fire calls, sitting quietly in the truck, eyes wide with admiration. He made her feel like she was part of something brave and important—because she was with him.

When he passed, her world changed—but her support system didn't falter. Her family was immediately embraced by the brotherhood of the fire service, surrounded by people who had loved and respected her father as deeply as she did. The Hundred Club and that community made sure she, her brother and her mother were never alone.

Today, Brianna is a vibrant 20-year-old pre-med student at Massachusetts College of Pharmacy and Health Sciences, and receives scholarship dollars from the 100 Club every semester to help with her expenses. Brianna carries every lesson, every memory, and every ounce of love he gave her. In the way she lives, in the strength she holds, and in the joy she still finds in the little things—just as he taught her.







Rich MacKinnon, President, Professional Fire Fighters of Massachusetts (PFFM)

Rich MacKinnon, President of the Professional Fire Fighters of Massachusetts, has seen the toll that active-duty deaths take on families—not just emotionally, but in the sudden wave of uncertainty that follows. In those moments, he says, the 100 Club becomes a lifeline.

"The Club doesn't wait," he often shares. "There's no red tape. No forms. No delays. When a firefighter's family is facing the worst day of their lives, the 100 Club is already there."

According to MacKinnon, one of the most impactful things the Club does is deliver immediate financial support—often within hours. That gesture is far more than a check. It's a clear message: "You are not alone. We are with you."

For families caught in the chaos of grief, that support provides space to breathe. It helps them focus on mourning and honoring their loved one, without the added burden of financial strain. MacKinnon has witnessed how deeply that immediate assistance is felt, and how powerfully it reinforces the strength of the firefighting community.

"The 100 Club doesn't just offer help," he says. "They offer hope. And sometimes, in those darkest moments, that's exactly what families need most."

2024 By the Numbers

Since inception, the Club has provided over \$20 million in benefits to almost 1,800 families of fallen heroes.

2024 was a historic year for the Hundred Club, filled with both triumphs and challenges. Thanks to your support, we were able to make a record-breaking impact, standing by the families of our fallen heroes during their most difficult moments. This past year, we supported more families than ever before, honoring the memory of those who made the ultimate sacrifice.

In 2024, there were three line-of-duty deaths and 16 active-duty non-line-of-duty deaths due to suicide, cancer, cardiac events, and brain hemorrhage. We will never forget these brave individuals, and we are committed to ensuring their legacies live on.

\$585,000 in immediate cash benefits to families—far surpassing our previous record of \$455,000 in 2022










These numbers represent more than just financial assistance—they are a promise that we will always stand by the families of our fallen heroes. None of this would be possible without you and your support of our mission.
